PORT OF DESTINATION CHARGES

Destination port charges such as destination handling charges, import customs clearing fees, and agency fees have to be paid to an agency at the port of destination. Please consult agencies in the destination country regarding destination charges before shipping your cargo, Emarat Shipping Inc. will not be responsible for pay destination charges.
